

Win Local With Elders – Terms & Conditions (Victoria)

1. Promoter

3. Promotion Period

The promotion commences at 12:00 am AEDT on 9th February 2026 and closes at 11:59 pm AEDT on 27th March 2026 (“Promotion Period”).

4. Eligibility

- 4.2** To be eligible, entrants must complete a property appraisal request during the Promotion Period.

5. How to Enter

- 5.1** To enter, eligible participants must request and complete a property appraisal by submitting the appraisal form via the Elders Real Estate Mansfield website during the Promotion Period.
